

Terms and conditions:

1. The promoter is: Life Flight Trust (charity no. CC24283).

Eligibility for Entry

2. The competition is open to residents of New Zealand except employees of Life Flight and their immediate families.
3. Entrants must be under the age of 16 to be eligible to participate.
4. By entering this competition, an entrant (or the parent/caregiver of the entrant) is indicating their agreement to be bound by these terms and conditions.
5. Only one entry will be accepted per entrant.
6. No donation is necessary to win or participate in the promotion.

Entry

7. Closing date for entry will be 14/05/2021. After this date no further entries to the competition will be permitted.
8. No responsibility can be accepted for entries not received for whatever reason.
9. The rules of the competition and how to enter are as follows:
 - a. Entrants must draw a scene involving one or multiple Life Flight aircraft (Air Ambulance Plane or Westpac Rescue Helicopter).
 - b. The picture must be uploaded to Facebook or Instagram by a parent or guardian if they are under the age of 13.
 - c. Life Flight must be tagged in some way, and the picture must be available for Life Flight to see.
10. The promoter reserves the right to cancel or amend the competition and these terms and conditions without notice in the event of a catastrophe, war, civil or military disturbance, act of God or any actual or anticipated breach of any applicable law or regulation or any other event outside of the promoter's control. Any changes to the competition will be notified to entrants as soon as possible by the promoter.
11. By participating, entrants (or the parent/caregiver of the entrant) grant Life Flight exclusive permission to use their names, characters, photographs, artwork, videos, voices and likeness in connection with the Promotion and for future promotion and marketing purposes and waive any claims to royalty, right or remuneration for such use.

Winning the prize

12. Only the person (or their parent/caregiver) who originally entered the Promotion can be awarded the prize (the 'Winner')
13. Winners will be chosen by the promoter who shall for this purpose be deemed the judge (**the 'Judge'**). The promoter's decision is final, and no correspondence will be entered into. Only one prize can be won per entry.
14. Winner will be drawn at 14/05/2021

15. No cash or other alternatives will be offered. The prizes are not transferable. Prizes are subject to availability and we reserve the right to substitute any prize with another of equivalent value without giving notice.
16. The Winner will be notified by email, phone (voice or text), mail or in person. Where attempts to contact the Winner fail (e.g. when the Winner cannot be contacted by phone after three attempts or mail sent is returned) the Judge will select another winner.
17. If the winner cannot be contacted or does not claim the prize within 14 days of notification, we reserve the right to withdraw the prize from the winner and pick a replacement winner.
18. The promoter will notify the winner when and where the prize can be collected / is delivered.
19. The promoter's decision in respect of all matters to do with the competition will be final and no correspondence will be entered into.
20. The number of people allowed on the Westpac Rescue Helicopter is the winner, parent or legal guardian and two others.
21. The Westpac Rescue Helicopter is in operation 24/7 and therefore may be subject to a call out at any point in time. In the case of a call out, Life Flight will, to the best of their ability, inform the prizewinner as early as possible and rearrange a time.

General

22. The competition and these terms and conditions will be governed by New Zealand law and any disputes will be subject to the exclusive jurisdiction of the courts of New Zealand.
23. To the fullest extent permitted by law Life Flight will not be liable for any loss or damage whatsoever (including but not limited to direct or consequential loss) or for personal injury as a result of Promotion entry or winning the prize.
24. Any personal data relating to the winner or any other entrants will be used in accordance with the Privacy Act 2020 and will not be disclosed to a third party without the entrant's prior consent.

Acceptance
